


## To access your 401k





### Identity verification

Enter your mobile phone number below to continue with identity verification.

By clicking "I agree, continue" you authorize us to send you a text with a verification code, and to validate your phone records with your mobile provider for the sole purpose of verifying your identity. These records may include access to public and proprietary sources and contain data such as your name, device, and billing information, as well as it may include your personal credit card profile and non-financial data. Accessing this data will not affect your credit score.

Once you click "I agree, continue" you will receive your verification code via text within five minutes. Use this code on the following page to continue the login process. If you prefer to skip this process, click "Skip, mail PIN" and a verification PIN will be mailed to your address on record.


